Description of first aid measures

Eye Contact	If this product comes in contact with the eyes: Nash out immediately with fresh running water. Minor Spills	Small spills should be covered with inorganic absorbents and disposed of properly. Organic absorbents have been known to ignite when contaminated with amines in closed containers. Certain cellulosic materials used for spill cleanup such as wood chips or sawdust have shown reactivity with ethyleneamines and should be avoided. Ethyleneamine leaks will frequently be identified by the odor (ammoniacal) or by the formation of a white, solid, waxy substance (amine carbamates). Inorganic absorbents or water may be used to clean up the amine waste. In remove all ignition sources. Clean up all spills immediately. Avoid breathing vapours and contact with skin and eyes. Exposure controls

Appropriate engineering controls

Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.

The basic types of engineering controls are:

Process controls which involve changing the way a job activity or process is done to reduce the risk.

Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use.

- Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lenses or restrictions on use, should be created for each workplace or task. This should include a review of lens absorption and adsorption for the class of chemicals in use and an account of injury experience. Medical and first-aid personnel should be trained in their removal and suitable equipment should be readily available.

The selection of suitable gloves does not only depend on the material, but also on further marks of quality which vary from manufacturer to manufacturer. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

The exact break through time for substances has to be obtained from the manufacturer of the protective gloves and has to be observed when making a final choice.

Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly

- When handling liquid-grade epoxy resins wear chemically protective gloves (e.g. nitrile or nitrile-butatoluene rubber), boots and aprons.
- ▶ DO NOT use cotton or leather (which absorb and concentrate the resin), polyvinyl chloride, rubber or polyethylene gloves (which absorb the resin).
- DO NOT use barrier creams containing emulsified fats and oils as these may absorb the resin; silicone-based barrier creams should be reviewed prior to use

Inhaled	There is some evidence to suggest that the material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Inhalation of epoxy resin amine hardeners (including polyamines and amine adducts) may produce bronchospasm and coughing episodes lasting several days after cessation of the exposure. Even faint traces of these vapours may trigger an intense reaction in individuals showing "amine asthma".

RADS (or asthma) following an irritating inhalation is an infrequent disorder with rates related to the concentration of and duration of exposure to the irritating substance. On the other hand, industrial bronchitis is a disorder that occurs as a result of exposure due to high concentrations of irritating substance (often particles) and is completely reversible after exposure ceases. Exposure to the material for prolonged periods may cause physical defects in the developing embryo (teratogenesis). The following information refers to contact allergens as a group and may not be specific to this product. Contact allergies quickly manifest themselves as contact eczema, more rarely as urticaria or Quincke's oedema. The pathogenesis of contact eczema Davco Epoxy Grout Part B involves a cell-mediated (T lymphocytes) immune reaction of the delayed type. Other allergic skin reactions, e.g. contact urticaria, involve antibody-mediated Hardener & immune reactions. The significance of the contact allergen is not simply determined by its sensitisation potential: the distribution of the substance and the TRIETHYLENETETRAMINE opportunities for contact with it are equally important. A weakly sensitising substance which is widely distributed can be a more important allergen than one with stronger sensitising potential with which few individuals come into contact. Davco Epoxy Grout Part B Ethyleneamines are very reactive and can cause chemical burns, skin rashes and asthma-like symptoms. It is readily absorbed through the skin and may Hardener & cause eye blindness and irreparable damage. As such, they require careful handling. In general, the low-molecular weight polyamines have been positive TRIETHYLENETETRAMINE in the Ames assay (for genetic damage); however, this is probably due to their ability to chelate copper. Davco Epoxy Grout Part B The alkyl polyamines cluster consists of two terminal primary and at least one secondary amine groups and are derivatives of low molecular weight Hardener & ethylenediamine, propylenediamine or hexanediamine. Toxicity depends on route of exposure. Cluster members have been shown to cause skin irritation or TRIETHYLENETETRAMINE sensitisation, eye irritation and genetic defects, but have not been shown to cause cancer. For ethyleneamines:

Adsorption of the ethyleneamines correlates closely with both the cation exchange capacity (CEC) and organic content of the soil. Soils with increased CEC and organic content exhibited higher affinities for these amines. This dependence of adsorption on CEC and organic content is most likely due to the strong electrostatic interaction between the positively charged amine and the negatively charged soil surface.

For alkyl polyamines:

All members of this cluster are miscible or soluble in water.

Environmental Fate: Members of this cluster are expected to have varying degrees of mobility in the soil. While models suggest that they are likely to react rapidly with photochemically produced hydroxyl radials (with half-lives of an hour), as they are do not readily exist in vapour form this is not expected to be a predominant removal pathway for these chemicals. Experimental data and results from estimation models indicate that all members of this cluster have the potential to biodegrade aerobically under environmental conditions. Models indicate that the members of this cluster are likely to partition predominately to soil and water. All chemicals in this cluster are expected to have low environmental persistence and a low potential for bioaccumulation. For Triethylenetetramine (TETA):

Log Pow (unprotonated form): -1.4; Vapor pressure: ca. 1 Pa at 20 C. Ethylenediamine: Koc � 4766; Diethylenetriamine: Koc � 19111.

Environmental Fate: High adsorption of ethylenediamine and diethylenetriamine is most likely due to electrostatic interaction. TETA has a high potential for geoaccumulation. TETA is not readily or inherently biodegradable and can be regarded as non-biodegradable.

Aquatic Fate: TETA is completely miscible with water forming an alkaline solution (pH 10 at 10 g/L).

SECTION 13 DISPOSAL CONSIDERATIONS

Waste treatment methods

Product / Packaging disposal

- ► Containers may still present a chemical hazard/ danger when empty.
- Return to supplier for reuse/ recycling if possible.

Otherwise:

- ▶ If container can not be cleaned sufficiently well to ensure that residuals do not remain or if the container cannot be used to store the same product, then puncture containers, to prevent re-use, and bury at an authorised landfill.
- ▶ Where possible retain label warnings and SDS and observe all notices pertaining to the product.

Legislation addressing waste disposal requirements may differ by country, state and/ or territory. Each user must refer to laws operating in their area. In some areas, certain wastes must be tracked.

A Hierarchy of Controls seems to be common - the user should investigate:

- ▶ Reduction
- Reuse
- Recycling
- Disposal (if all else fails)

If it has been contaminated, it may be possible to reclaim the product by filtration, distillation or some other means. - Bury or incinerate residue at an approved site.
